Good Afternoon:

Please ensure this information reaches the functional and IT personnel in your agency who are responsible for configuring and maintain your agency's SCEIS interfaces as soon as possible.

In July, the SCEIS Team sent you a detailed memo, along with updated Interface Operational Guides (IOGs), to assist your agencies in making changes to the IF383A AP Direct Pay Invoices Inbound Interface and the IF389 Accounts Payable (AP) Outbound Interface. These changes are necessary to ensure your agency is able to receive the updated interface files that will be used after the State Treasurer's Office converted processing of Contingent Checks from STARS to SCEIS. The date for this conversion was originally set for August 24th, but was postponed.

The SCEIS Team is pleased to announce that a new conversion date has been identified: Friday, October 19, 2012. This means that we will begin using the new IF383A and IF389 file formats on Monday, October 22, 2012.

To help you finalize your preparations to begin utilizing the new file formats, we have provided links to all pertinent information, which is available on the SCEIS website. In addition to this information, we have also included additional details about how check numbers are formatted in the revised IF389 interface files, and a screen shot to help illustrate this information.

## Additional Details on Check Number Formats in IF389 Files

- 1. Check Payments will only receive a Check Number:
  - a. EDI Reference Number and EDI Trace Number will be blank.
- 2. ACH Payments will receive an EDI Reference Number and EDI Trace Number:
  - a. Check Number will be blank.
- 3. EDI Reference Number will be the same for all payments on one Payment Run and EDI Trace Number will be unique for each payment within that Payment Run.
- 4. Check/EDI Date and Check/EDI Amount will be used for both Check and ACH Payments.
