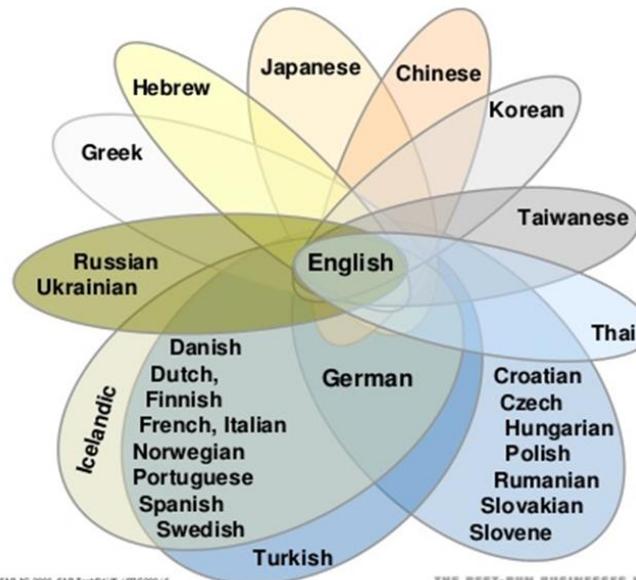


🔄 System Upgrades and Enhancements

– **OnBase:** Data and document classification

– Unicode Migration

- Unicode is a data format that allows SAP to accept multiple languages.
- SCEIS will migrate all data storage to Unicode to enable future SAP upgrades.

– Enhancement Pack 8: HANA & Fiori

HANA

- In-memory data processor
- Rapidly processes data to provide real-time analytics



Fiori

- Collection of apps
- Enables users to perform routine tasks on a variety of devices



– **Dell Password Management:**

- Upgrade from IdM Password Management tool to Dell Quest Password Management tool
- Password reminders and self-service password reset
- Improved user experience and enhanced security

– **ServiceNow:**

- Upgrade Help Desk system from CA Service Desk to ServiceNow
- Used for password and Basis requests
- More efficient service to users

🔄 Improved Performance and Efficiency

- **Archiving:** Archive data from SAP to improve performance and speed recovery times.

🔄 New Functionality

- **HHS - Phase 2:** Leverage existing accounting and finance functionality in SCEIS to pay Medicaid providers for services delivered to the State's Medicaid recipients.
- **Plant Maintenance:** Organize and manage inspection, preventive maintenance, and repair of state property.
- **Real Estate Management:** Organize and manage the real estate portfolio for the state.
- **Revenue Project:** Tax refund payments in SCEIS
