Supplements	Additional budget authorized by the state for specific purposes.
Tax Amount	Calculated tax for the Base Amount and tax jurisdiction code.
Tax Base Amount	Dollar amount on which the tax is assessed.
Tax Code	2-character code to determine the tax process used - tax exempt, taxable, Use Tax, etc.
Tax Doc Item	Line item number on the purchasing document for which tax is assessed.
Tax Jur - Lower Level	The tax jurisdiction is used for determining the tax rates in the USA. It defines to which tax authorities you must pay your taxes. It is always the city to which the goods are supplied - in conjunction with VERTEX.
Tax Jurisdiction Code	Identifying number used to determine the tax rate for a higher-level location – the first six digits of the Tax Jurisdiction which is the lower level code followed by four zeros. This would be for the state or county high level. Tax Jurisdiction at the lower level would provide info for incorporated or unincorporated areas based on address.
Tax Jurisdiction Levy	This field represents the tax jurisdiction level — state, county, etc. — for the tax processed to the Department of Revenue when sales tax is not collected by the vendor.

Transaction Type	The transaction type in asset accounting classifies the business transaction. The transaction type controls various system activities when business transactions are posted.



Transfer Credits	For assets which transfer an amount to a different asset.

Transfer Receiver	Summary of budgets received via the transfer FMBB transaction.
Transfer Sender	Summary of budgets sent via the transfer FMBB transaction.

Value Option	In this field, you use the operators to define the entered values as a single value, range or search pattern for the purposes of restricting data selection. The available operators are: EQ Equal BT Between LE Less Equal GE Greater Equal CP Contains Pattern
Value Sign	 This field allows you to enter either "I" or "E". "I" (Inclusive) means that the single value or range you specified is selected itself. "E" (Exclusive) means that the single value or range you specified is excluded from the selection. The default is "I".

Value Type in FM	The value type is a technical classification feature for individual business transactions. Version	This field is a standard field within the DSO used for this query. Currently SCEIS only has one version (1).
Void Check Date	Date a vendor payment check was voided.
Void Reason Code	Reason why a check issued to a vendor has been voided.
Void Reference Code	Reason why a check issued to a vendor has been voided.
Voided Check Date	Date a vendor payment check was voided.
WBS Element	WBS Element is used to collect the activities belonging to a part of a project. A cost collection object like Internal order, Cost Center, etc.
Workflow Status	The state of a processing step or action to complete a tasking within SCEIS. Example include In Process, Completed, Errored, Logically Deleted.
Year End Adjustments	FM entries to affect the fiscal year-end. Examples include carry-forward entries, returns.
Year to Date Amount	Results column showing the FY to Date summary amount for the report row.
YTD Actual Expense	Results column showing the FY to Date Actual Expense, excluding commitments, summary amount for the report row.



YTD Actual Revenue	Results column showing the FY to Date Actual Revenue, excluding estimates, summary amount for the report row.
YTD Beginning Cash Balance	The cash balance for the report's row at the beginning of the fiscal year.
YTD Ending Cash Balance	The cash balance for the report's row at the end of the fiscal year. This is a calculated field for the report.
